## A MODULAR TRAINING PROGRAMME TAILORED TO YOUR LOCAL AUTHORITY

The Legislative Training Programme addresses key legislation in the following areas: Governance and Reform, Housing, Planning, Environment, Water and Roads & Transportation Services. It looks at how legislation shapes Local Government structures and is suitable for middle to senior management levels.

The programme combines theory and practice with case studies and bespoke resources for each local authority. This is a modular learning programme, where participants will attend interactive sessions and have access to the course material and additional resources on Moodle. The course can be delivered in person or online.

This modular programme, delivered over six days, delves into legislation pertaining to the areas of Housing, Planning, Environment, Water and Roads & Transportation Services. It also looks at Local Government structures and the history of reform. The programme will also examine some general law issues such as injunctions, judicial review and court cases and the implications of these for Local Government from the perspective of an experienced legal professional.
